Clerk's Note: The Chair of the Finance Committee asked for a supension of the rules to poll his committee as there was a requested amendment to the language of the Whistleblower Policy that had been offered after the Finance Committee had voted on the item. The Amendment that was offered included a new last sentence in the Reporting Section of the policy. The new last sentence for this section reads: "If a whistleblower has reported directly to the Chair of the Financial Audit Advisory Committee, the Chair of the Financial Audit Advisory Committee will inform the Chair of the Finance Committee as soon as possible." The Finance Committee voted to approve this amendment.

The item was then placed on Second Call. On Second Call two additional amendments were offered. The first was to the Process section of the policy. The first line was amended to strike the word "first" and to add at the end of the sentence the following text: "unless they are implicated in such activities or reporting." The second amendment was to the Protection Against Retaliation section. It added the following text to the first sentence after the words employment record,: "unwanted transfers to new locations or new units," and removed the words "poor work

assignments" from the sentence. The amended policy was approved by the Board by Voice Vote.
