Newton ARPA Investment Newton Highlands Village Center - \$1,000,000 (\$250,000 in Oct. 2021 & \$750,000 in Sept. 2022)

October 2021 Announcement

Newton has wonderful village centers that serve as centers of business, public transportation, shopping and dining, a variety of housing types, and community gatherings. The pandemic created great stress for much of the village center-based business community at a time when many residents have been staying closer to home looking for dining, walking and biking destinations, and easy shopping.

The City recently completed village center improvement projects in Newtonville and West Newton Square with street, sidewalk, biking, and lighting improvements and more trees, benches and art. Residents and businesses helped us design the improvements.

I have decided to commit \$250,000 of American Rescue Plan Act (or ARPA) funds to begin the engagement and design process for a streetscape improvement project that will update the heart of Newton Highlands. Upon completion, this exciting infrastructure project will support a multimodal, business-friendly, resilient, inviting village center to accommodate all modes of transportation (pedestrian, bicycle, vehicular, and public transit users).

The project will proceed in phases. We'll begin by gathering ideas and information from residents, business owners, City officials, Area Council members and key constituent groups; by thoroughly analyzing and assessing existing conditions; and by identifying conceptual alternatives for improvements. The one selected as the preferred alternative at the conclusion of this <u>Engagement and Conceptual Design Phase</u> will be advanced through the <u>Preliminary and</u> Final Design Phases, and ultimately the Construction Phase.

Our goal in our village center projects is to have "livable streets" with an enhanced, resilient environment for our businesses and surrounding neighbors to thrive. We look forward to lots of input in the coming months on the Newton Highlands Village Center.

September 15, 2022 Announcement

With the public engagement process well underway, I am allocating an additional \$750,000 in ARPA funds for the <u>Preliminary and Final Design phases</u> of this project to allow it to keep moving forward through 2023 and get to a "shovel ready" stage. Meanwhile, we will be actively seeking state grant and earmark sources of funding for the Construction Phase of the project. The

expansive funding for design is larger than one might think due to a number of important factors. The Highlands area includes two signalized intersections which are complicated and expensive to address. There are also new stormwater management requirements that will require extensive design work. Professional services have also increased in cost during this inflationary period. Hopefully not all of the APRA funds will be needed for the design phase. Any leftover funds could either be used for early-action construction items (if the timing corresponds with APRA requirements) or be returned to the City's ARPA program for re-allocation.
