### 1. Introductions (3:30-3:35)

Meeting started at 3:35pm with introductions.

#### 2. Approval of February 28, 2022 Meeting Minutes (3:35-3:40)

Rob asked if minutes were read and if there were any changes or comment. No comments. Lucie made a motion to accept the minutes as presented, Nancy seconded the motion. Rob asked all in favor say yes, four yes, no no's. Motion passed unanimously.

### **3.** ARPA Funding Request (3:40-3:55)

Rob asked Jini if she had heard if there was any news regarding the ARPA funding request and Jini replied that she heard that the mayor received the report. Eileen said that the Co-Chairs received acknowledgement that the mayor did receive it.

### **4.** Mission Statement (3:55-4:10)

A compilation of all present. Rob said this is the Funding Subcommittee for the Benefit of People with all Disabilities. This includes people with mobility, vision and hearing loss along with barrier removal as well as people with developmental and intellectual disabilities and mental health issues. This also includes accessibility to programs and services essential to all people with all disabilities. This subcommittee's aim is to locate adequate sources of funding local, state, federal and private to make Newton more accessible, livable and welcoming to people with all disabilities. It is imperative that funding be allocated on a timely basis because safety and other factors are usually a necessary component for people with disabilities. According to the latest statistics from Massachusetts Easter Seals 1 in 4 people or 25% of the population have a disability. As our population ages, living longer will only increase these numbers.

# **5.** New/Existing Programs/Services for People with Developmental & Intellectual Disabilities (IDD) and Mental Health Disabilities (4:10-4:30

Lucie wanted to clarify that all mental health issues should not be lumped together. IDD is Intellectual Disabilities and Developmental Disabilities. She said that funding for people with IDD is severely lacking. Councilor Bowman said she was greatly concerned with accessible/affordable units at Northland's new project on Needham Street. Lucy said that she wanted to see a new program using 30% of AMI because people with IDD and mental health difficulties are under employed or not employed.

### 6. Discussion for Other Projects (4:30-4:50)

Discussion ensued about housing voucher programs. Girard talked about the Alternative Housing Voucher Program (AHVP) and how that was used for people leaving nursing and rehab facilities. It is funded by the state of Massachusetts. Jini talked about the Section 8 Voucher Program and how difficult it is to get one. The other programs include Newton Housing Authority (NHA), the Newton Community Development Foundation (NCDF), CAN-DO, and Community Preservation Committee (CPC) Housing Fund.
