# Community input results on village center zoning framework

From September 1st through October 17th, community members gave input on a proposed framework for updating the city's village center zoning. About 1,000 folks submitted the feedback tool, attended equitable focus groups and visited the library exhibit.

City staff will present a synthesis of what they heard from the community at the virtual Zoning and Planning Committee (ZAP) meeting of November 14th, 2022. <u>Click here for the staff memoreleased on November 10.</u>

Following this presentation, city responses to the engagement results will be discussed more in depth at the ZAP meeting on Monday, November 28th, where the first draft of zoning text for the

village centers will be presented.

#### **Mapping - October 24 ZAP Recap**

Planning staff and consultant Utile presented <u>version 1.0 of the village center zoning districts</u> to ZAP at their October 24 meeting. This initial mapping process ran in parallel to the recent engagement, mentioned above, and builds upon nearly two years of research, analysis and City Council deliberation.

In short, the version 1.0 village center district maps propose three new village center zones that could be applied in twelve of our village center commercial areas. Unlike the current zoning, with its one-size-fits-all format, Utile and Planning staff customized these new zoning districts to each village center.

This first draft is intentionally meant to be reviewed and updated. Future updates to the draft maps will incorporate the recent engagement results, input from ZAP workshops at upcoming meetings, and comments gathered through future public information sessions. At the October 24 ZAP meeting, Councilors were particularly interested in learning more about how overlay districts work, impacts on existing special permits, including other areas like the Boston College T station, and the connection with the MBTA Communities requirements.

These virtual sessions, focused on one or two village centers per meeting, will provide community members with an opportunity to provide feedback on these initial maps. The sessions will prioritize hearing from the property owners and businesses located within the proposed rezoning districts.
