Question 1

Proposed constitutional amendment would establish an additional 4% state income tax on that portion of annual taxable income in excess of \$1 million.

Question 2

Proposed law would direct the Commissioner of the Massachusetts Division of Insurance to approve or disapprove the rates of dental benefit plans and would require that a dental insurance carrier meet an annual aggregate medical loss ratio for its covered dental benefit plans of 83 percent.

Question 3

Proposed law would increase the statewide limits on the combined number of licenses for the sale of alcoholic beverages for off-premises consumption (including licenses for 'all alcoholic beverages' and for 'wines and malt beverages').

Question 4

This law allows Massachusetts residents who cannot provide proof of lawful presence in the United States to obtain a standard driver's license or learner's permit if they meet all the other qualifications for a standard license or learner's permit, including a road test and insurance, and provide proof of their identity, date of birth, and residency.

√Yes: 24,717

Today's results are still unofficial. They include mail-in ballots the City has received, early voting in-person ballots and votes cast in person today. Newton Uniformed and Overseas Citizens Absentee (UOCAVA) ballots and provisional ballots will be counted by hand and added to the official tally. (Click here for information on provisional ballots.)

Mail-in ballots postmarked on or before Nov. 8 and received by Saturday, Nov. 12 at 5:00 p.m. will be added to the official tally through public hand counting starting on Nov. 14 at City Hall.

As of the end of the day yesterday, Monday, Nov. 7, the City had received ballots from 17,308 voters, cast either in person during early voting or mailed in.

As of tonight, the City has counted ballots from 35,392 of the City's 60,040 registered voters, or 59%. In the last State Election in 2018, when the official results were in, 68%, or 40,831 of the City's 60,346 registered voters cast ballots.

The Election Commission will meet on Tuesday, Nov. 22 and the certified results will be sent to the State on November 23 by City Clerk Carol Moore.

I thank City Clerk Carol Moore, our election, IT and police staff, poll workers and volunteers who worked not just today but over the course of the past five months to run the state primary and today's election.
