#528-22 Request for discussion and ordinance to prohibit deceptive advertising by

limited-service pregnancy centers

COUNCILORS HUMPHREY, NOEL, BOWMAN, RYAN, NORTON, LEARY, LUCAS, MALAKIE, WRIGHT, AND DANBERG requesting discussion to prohibit limited-service pregnancy centers from making deceptive advertisements concerning pregnancy-related services or the provision of pregnancy-related services,

including implementing a penalty for violation of the ordinance.

Action: <u>Programs & Services Held 8-0</u>

**Note:** Alissa Giuliani, City Solicitor, and Councilor Kristen Strezo of Somerville were introduced. Councilor Humphrey as lead docketer presented on the item noting the state of abortion rights after the Dobbs v. Jackson Women's Health Organization decision (597 U.S. \_ (2022)). In the aftermath of this decision, Massachusetts has seen an increase in out-of-state

residents seeking abortion care within the state. He also noted the possibility of future items being docketed related to limited-service pregnancy centers. The proposed ordinance seeks to promote accurate information for those seeking abortion care. A limited-service pregnancy center that engages in these deceptive advertising practices would be subject to a three hundred dollars (\$300) fine. Enforcement of this ordinance would be through the Health and Human Services department.

Councilor Strezo of Somerville noted that these facilities have existed within Massachusetts for decades and further an anti-abortion agenda. Licensing for these facilities is mostly as a business or religious institution and marketing mimics that of health centers. It was also noted that these facilities are not bound by HIAA (Health Insurance Portability and Accountability Act of 1996) and are staffed by unlicensed volunteers. When referring to a similar ordinance in Somerville, Councilor Strezo stated that this ordinance was done proactively.

The Chair noted the need to create a distinction between the municipal and state roles regarding this topic. Attorney Giuliani urged the Committee to be careful and noted considerations regarding the First Amendment and the role of a municipality that should be kept in mind throughout these discussions. Current actions taken by the Consumer Advocacy and Civil Rights Divisions of the Attorney General's office regarding limited-service pregnancy centers were also outlined.

Resulting from the discussion the Chair outlined the following eight main questions regarding this ordinance:

- What are potential zoning and/or licensing remedies that could be taken?
- Is it appropriate for the City to prohibit deceptive advertising?
- What is role of enforcement in Health and Human Services versus Inspectional Services?
- Whether a distinction between free and paid services should be made?
- What would implicate First Amendment religious freedoms, and could there be a content neutral way to limit or restrict these facilities in the City?
- What does a process that distinguishes the municipal and state roles look like?
- Are practitioners at these facilities able to provide services without proper licensure or training?
- What is the role of the City in validating state licensure?

The Committee voted 8-0 on a motion to hold from Councilor Ryan.

# #411-22 Request for Amendment to Chapter 21, Art III Trees to extend tree protection and update permits

COUNCILORS MALAKIE, NORTON, LEARY, RYAN, WRIGHT, LUCAS, HUMPHREY, BOWMAN, MARKIEWICZ, OLIVER, DOWNS, LAREDO, AND GROSSMAN requesting revisions and amendments to Chapter 21, Art. III Trees (sec. 21-60 through 21-89) to extend tree protection to all trees 6 inches DBH (diameter at breast height) and greater within the City (with no exempt lots); to update tree removal permits, fees, and compensation; and to strengthen protection for existing and replacement trees.

III, Division 3, Tree Preservation to increase replacement requirements for larger trees, add protections for smaller trees, limit removal of trees without replacement, enhance procedures for protecting trees, increasing payment required for trees cut without replacement, protect trees on lots adjacent to construction, provide Tree Warden with additional professional input on trees on private properties.
