#481-22 Reuse of parcel of land on Jackson Road

<u>DIRECTOR OF PLANNING & DEVELOPMENT</u> submitting on October 6, 2022 a letter stating that the 57 sq. ft. City owned parcel of land known as 181-183 Jackson Road, should be made available for sale or lease, pursuant to the City of Newton Ordinances Section 2-7.

Clerk's Note: Councilor Malakie expressed concern about heat islands, the loss of green space, and setting a precedent for these types of easements--while at the same time, wanted to balance her concerns with the needs of this family, who have a child with a disability. This easement would provide easier access to their parking space--important for transportation to hospital visits.

#17-23 Appropriation of \$3,240,000 for Newton South High School Fields and Track

<u>HER HONOR THE MAYOR</u> requesting authorization to appropriate and expend the sum of three million, two hundred forty thousand (\$3,240,000) in FY2022 Free Cash for synthetic turf carpet and infill materials, installation, and construction oversight to replace the two (2) synthetic turf fields at Newton South High School and to resurface the perimeter track at the school's Winkler Stadium.

Clerk's Note: Councilor Krintzman gave some background: turf has an 8-10 year life span, and these turf surfaces have been in place for 13 years. They do possibly contain PFAS, which is considered to be a toxic "forever chemical". A citizen's petition, which has not yet been successfully submitted, is underway, and has over 50 signatures, which meets the signature threshold to require the City Council to act within 3 months (or at least begin taking action), and to have a public hearing. Councilor Downs proposed a motion to postpone the vote to a date certain, which will allow the citizen's petition to be filed and docketed, and to hold a public hearing first—before voting on this item. Councilors had a discussion regarding delaying a vote versus voting tonight and then possibly reversing the decision late (after the public hearing had been held). Councilors were concerned about the safety issues, both from re-doing tge turf surface, and also from not re-doing the turf surface. Some Councilors felt that the newer materials had less chemical content and were less toxic and more environmentally-friendly; other Councilors were extremely concerned about the toxicity of PFAS.
